1. Do not injure or damage any structure, rock, tree, flower, bird, or wild animal within the campground. Dead tree limbs can be used for firewood with the approval of the campground board.
2. Any firearm, BB gun, air gun, CO2 gun, bow and arrow, or spear gun in possession in the campground must be unloaded or unlocked and stored in a case or locked within a vehicle except when participating in an approved activity. All activities must be under adult supervision and in a designated location and with approval of the caretaker.
3. Dogs, cats, and other pets must be kept on a leash no longer than six feet while in the campground.
4. There shall be no vending or advertising without the permission of the campground board.
5. Camping is permitted within the campground with approval of the caretaker. Youth groups must be under adult supervision.
6. Fires shall be built only in places designated and provided and with the approval of the caretaker.
7. Motorists will observe speed limits as posted and park in designated.
8. Swimming is limited to such places and times as designated by the campground board.
9. Drinking water shall be taken only from pumps, hydrants or fountains provided for that purpose. This water is tested for purity.
10. Report all lost or found items to the caretaker.
11. All motorized vehicles must remain on designated roadways. Snow mobiles are prohibited. Use of ATVs, golf carts and other similar vehicles must be used only with approval of the caretaker.
12. The campground will be closed from 11:00 pm until 7:00 am, please obtain approval from the caretaker to enter or exit during these hours.
13. The facilities of the campground will be left in the condition and order that they were in upon your arrival. Report all problems, leaks, and breakages at once to the caretaker. Not only is the campground not your property, it is the property of God. Bunks and other equipment will not be moved out of the cabins or other buildings without the approval of the caretaker.
14. Campground facilities, buildings, and equipment are available for use at the discretion of the caretaker and the campground board. Facilities, buildings, and equipment will not be used without permission of the caretaker.
15. Please let wild animals remain wild. Feeding of deer is prohibited. Feeding of wild animals can result in harm to both animals and people. Animals that depend on handouts become a nuisance to campground users and a danger to themselves. Please lock up all food and coolers inside cars, campers, or cabins. Roll car windows up tightly.
16. While the campground is located in a rural area, there are residential neighbors that reside nearby. Noise will be kept to a level that does not disturb neighbors and users of the campground will not trespass onto property not owned by the campground.

Campground Use Agreement and Contract

This agreement by and between FBC Christian Youth Campground and _____

(Name and address of user) will take effect on ____ day of _____, _____ and will continue for a period of _____ days.

WHEREAS, FBCCYC owns premises located at the above address which is normally used for Christian Adult and Youth events and WHEREAS, User desires to use the campground for the purpose of _____ and WHEREAS FBCCYC has agreed to allow the User to use the campground facility provided the following terms and conditions are met.

1. FBCCYC agrees to let User use the campground for the above described purpose on _____. _____ is the contact person for FBCCYC and _____ is the contact person for the User to coordinate the details of usage.
2. User agrees to pay FBCCYC _____ for the use of the campground.
3. User agrees that it will not use the campground for any unlawful purposes, and will obey all laws, rules, and regulations of all governmental authorities while using the campground.
4. User agrees that it will not use the campground for any purpose that is contrary to the mission, purpose, or belief of the Campground.
5. User agrees to abide by any rules and regulations fro the use of the campground that is attached to this agreement.
6. User promises and warrants that it carries liability insurance with a minimum liability occurrence limit of \$1,000,000. The User will provide a certificate of insurance to the campground at least seven days prior to the date upon which the user begins to use the campground. The certificate of insurance will indicate that the User has made FBCCYC an "additional insured" on User's policy with respect to the use by User of the campground.
7. User agrees to hold harmless, indemnify and defend FBCCYC (including agents, employees, and representatives) from any and all liability for injury or damage including, but not limited to bodily injury, personal injury, emotional injury, or property damage which may result from any person using the above described premises, its

entrances and exits, and surrounding areas, for User's purposes, regardless of whether such injury or damage results from the negligence of FBCCYC (including agents, employees, and representatives) or otherwise.

8. User agrees to be responsible for preparing of for use and returning to pre-use condition all areas of the campground which User will use, including entrances and exits.
9. User agrees to conduct a visual inspection of the campground, including entrances and exits, prior to each use and warrants that the campground will be used only if it is in a safe condition.
10. This agreement may be cancelled unilaterally by either party with 14 days written notice to the other party.
11. User agrees that it will not assign any of its rights under this agreement, and any such assignment will void this agreement at the sole option of FBCCYC.
12. This document contains the entire agreement of the parties and supersedes all prior written and/or agreements relating to the subject matter.
13. The campground maintains the right to refuse use to any group that has violated the rules of use as agreed.
